Town will supply, as hereinafter provided, to subscriber services and subscriber must provide, free of charge to the Town a place satisfactory to Town for a meter, subscriber will protect meter at all times and guarantees its return in good condition. Subscriber will file with the Town a deposit as continuing security for the performances of all obligations, including the discharge of all debts for services rendered until notice is given by subscriber for discontinuance of said service.

Town will use all reasonable diligence within its power to provide uninterrupted services, but does not guarantee a constant supply, or the quality, or suitability of water, and will not be liable for any damages to persons or property caused by either failure in constant supply, or by unsuitableness, or quality.

Town reserves the right to cancel this application and contract, and to the refund the deposit if the cost to the town of making connections should be excessive.

Failure by subscriber to promptly pay bills for services rendered by Town, under this contract at the stated location, or elsewhere in the service district, shall terminate and cancel all the subscriber’s rights hereunder, and the Town may discontinue its services as set forth by Town Ordinance.

In the event it becomes necessary to discontinue services for nonpayment of any service rendered under this application, subscriber agrees to pay the Town the service charge of disconnecting and connecting meter upon reinstatement of service as set forth by Town Ordinance.

Failure by subscriber to promptly pay bills for services rendered by Town, under this contract at the stated location, or elsewhere in the service district, shall terminate and cancel all the subscriber’s rights hereunder, and the Town may discontinue its service and remove its meter.

In the event it becomes necessary to discontinue services for nonpayment of any service rendered under this application, subscriber agrees to pay the Town the service charges of disconnecting and connecting meter upon reinstatement of services as set forth by Town Ordinance.

Subscriber shall pay for all services until notice is given by subscriber for discontinuance of services, and until proper time allowed for Municipality to thereafter finally terminate the services of by removal of meter

Failure by subscriber to apprise the Town of changes of mailing address may result in discontinuance of services by removal of meter.

Reference is hereby made to the Resolutions and Ordinances of the Town relative to water, sewer disposal as if copied in full herewith.

This contract contains all the terms of the agreement and no oral understandings are binding.

The applicant agrees that they have followed the guidelines set forth by the State Department of Health regarding onsite wastewater disposal.
